Axion Trader™ Program



Axion Trader™ Program is a capital allocation program designed by Axion Trade, that provides the funding, to assist aspiring professional traders on their journey to becoming prop traders. Our ability to identify trading talent through our proprietary Axion Scoring System™ algorithm is the basis of this program. The program has three progressive phases: Novice, Advanced and Pro.

HOW TO QUALIFY FOR Axion Trader™

6 months track record. You can qualify for an evaluation to join Axion Trader™ by providing the investor password login from to any MT4 trading account to scoring.system@axiontrade.net

(Please state clearly in the email the Server, Login ID and Investor Password and send the email from your registered email address with Axion Trade)

- Score 70 or more
- ✓ Minimum account equity for consideration 1,000 USD
- The account must be profitable from the time of inception (percentage and absolute gain >0)

START OF NOVICE

- ✓ A trading account is setup with Axion Trade
- ✓ Minimum trading account equity of 1,000 USD

Criteria for promotion to Advanced

- A minimum of three months in Novice
- The trading account has a score of 80 or more rated by Axion Scoring System™
- The trading account must be **profitable** (percentage and absolute gain >0)
- The trading account should have at least 10 trades (running or closed) within the last month

How to Qualify

HOW TO QUALIFY FOR Axion Trader™

- Open a trading account with Axion Trade and fund a minimum of 1,000 USD for an evaluation period. You can qualify for an evaluation period to join Axion Trader™ by sending an email to with your registered email address at Axion Trade to scoring.system@axiontrade.net
- Please state clearly in the email the trading account ID (MT4) that you would like to include your MT4 account for the evaluation period.
- ✓ Trade on your trading account for a full 3 months
- ✓ Score 70 or more
- The account will need to be profitable by the end of the full 3 months (percentage and absolute gain >0)
- Additional account deposits or withdrawals not allowed on the account during the 3 months of evaluation, you may open another trading account (MT4) with an additional deposit if you wish to try again.

Criteria for promotion to Advanced

- ✓ A minimum of three months in Novice
- The trading account has a score of 80 or more rated by Axion Scoring System™
- The trading account must be profitable (percentage and absolute gain >0)
- The trading account should have at least 10 trades (running or closed) within the last month

How to Qualify

- ✓ Went through Novice Phase
- The trading account score has a score of 80 or more
- Minimum trading account equity of 2,000 USD
- The <u>trading account</u> must be **profitable** (percentage and absolute gain >0)

Criteria for promotion to Pro

- ✓ A minimum of full 6 months
- ✓ The trading account has a score of 85 or more
- The trading account must be **profitable** (percentage and absolute gain >0)
- The trading account should have at least 10 new trades (running or closed) within the last month

Pro Phase

How to Qualify

- ✓ Completed Advanced
- The <u>trading account</u> has a **score of 85** or more
- Minimum trading account equity of 2,000 USD
- The <u>trading account</u> must be **profitable** (percentage and absolute gain >0)

How to Qualify for Additional Funding (Up to 500,000 USD)

In order to qualify for additional funding, the trading account must have grown by a **minimum of 10%** in the prior month and must be profitable since qualification for the Axion Trader™ program (percentage and absolute return >0).

The initial [10x] Multiplier from the Advanced phase carries over to the Pro phase, with an additional [10x] Multiplier funded the following month if the requirement is met, up to a maximum of [50x] Multiplier for each pro. For example, a Pro Trader with an initial trading account balance of 5,000 USD when promoted to a Pro Trader can receive funding up to 250,000 USD based on a [50x] Multiplier.

Additional deposits or rolling of profits are allowed as a Pro Trader (up to 10,000 USD), to maintain or increase the funded amount. In the same fashion, withdrawals will reduce the funded amount as it is calculated based on the multiplier.

The maximum funding for a Pro Trader is 500,000 USD (10,000 USD in the trading account with a [50x] Multiplier).

Furthermore, Pro Traders will qualify for investment from investors on the Axion Trade Copy Trading platform (coming soon), which further boosts their allocated capital. Pro Traders will be able to control the performance fee from these copy trading investors (as compared to the flat 20% profit sharing from Axion Trader™ Program).

Rehabilitation (applied to all 3 Phases)

Criteria for being moved to Rehabilitation

√ 10% Drawdown in the trading account at any given time

Terms and Conditions of Rehabilitation

<u>First Rehabilitation</u>: you will be invited back into the previous Phase (e.g., Pro to Advanced) one month after being placed into Rehabilitation).

<u>Second Rehabilitation</u>: you will be invited back to the previous Phase two months after being placed into Rehabilitation.

Third Rehabilitation: your funding will be forfeited, and you will be invited back to the Novice phase 3 months after being placed in Rehabilitation if your trading account meets the Axion Trader™ program (Axion Scoring System of 80 points or higher).

Rules for exiting Rehabilitation

- ✓ The Rehabilitation period ended
- You have an active trading account with Axion Trade which meets the Axion Trader™ requirements and is not already a trading account under the Axion Trader™ program. It can be the active trading account in rehabilitation or another active real account.

Rules for automatically being dropped from Axion Trader™ (applied to all Phases)

- ▼ Third Rehabilitation
- ✓ On Novice phase, trading account score dropping below 65
- On Advanced phase, trading account score dropping below 75
- ✓ On Pro phase, trading account score dropping below 80

Axion Trade reserves the right at its sole discretion at any time to cancel a trader's funding if it feels the information the trader has supplied is questionable or that they pose a risk to Axion Trade

Criteria for being moved to Inactive (applied to all Phases)

- Trading account or alternative trading account qualified for re-instatement from Rehabilitation, but trader decided not to continue participation in Axion Trader™
- Execution of both items below:
 - Trader withdrew all funds from his trading account, or there were no new or opened positions during the last month on the trading account
 - On an Axion Trade team request to clarify his participation status, the trader replied that they decided to stop participation in the Axion Trader™ program OR there is no reply after one week of sending the email.
